Such a Notice of Dispute shall be filed with CFX's Procurement Director. The Notice of Dispute shall specifically state that the contractor is disputing the Notice of Intent to Award Task Order and shall state with specificity and particularity the basis of the dispute. The timely filing of the Notice of Dispute is a jurisdictional requirement and failure to timely file a Notice of Dispute constitutes a waiver of the right to challenge the award. The Procurement Director, in conjunction with the requesting department, will review the Notice of Dispute, and has the authority to: (a) reject the dispute and proceed with the award; (b) accept the dispute, in whole or in part, and determine an appropriate course of action; or (c) reject all bids. The Procurement Director's decision is final.
